### Detailed Monthly information for the month of May, 2023

Important Policy decisions taken and major achievements during the month:

#### MINISTRY OF CIVIL AVIATION

1. New Civil Enclave at Kanpur (Chakeri) Airport inaugurated by Hon'ble Chief Minister of Uttar Pradesh and Hon'ble Minister of Civil Aviation on 26.05.2023.
2. A delegation from the Ministry of Civil Aviation, headed by Secretary (CA) and consisting of officials from the Ministry and Directorate General of Civil Aviation, attended the second ICAO Global Implementation Support Symposium (GISS) 2023 in Seoul, Korea from 30th May to 1st June, 2023. The delegation also signed a Memorandum of Understanding on Air Services matters with the Korean side during GISS 2023.
3. The Ministry granted permission for operation of charter flights from Afghanistan, Turkey and Sri Lanka under special circumstances.
4. Eight hundred and eighty three drones were registered and Unique Identification Number (UIN) were issued.
5. Four hundred and forty eight Remote Pilot certificates were issued.
6. Six new Remote Pilot Training Organisations (RPTO) commenced.
7. Two new RCS routes commenced.
8. AAI Cargo Logistics & Allied Services Company Ltd. (AAICLAS) commenced cargo operations at the following airports:
  - i. Domestic air cargo terminal at Indore with Regulated Agent (RA) on 25.05.2023.
  - ii. International Air Cargo operations with Regulated Agent (RA) at Mangalore Airport on 02.05.2023.
  - iii. Domestic air cargo operation from interim setup at Darbhanga airport on 19.05.2023.
  - iv. Commissioned Air Cargo movement through Airline Self-Handling by M/s Indigo for Outbound Air Cargo Operations at:
    - a. Patna: 23.05.2023
    - b. Hubballi: 23.05.2023
