Important Policy decisions taken and major achievements during the month:

1. Ministry of Civil Aviation

- (i) Passengers carried by domestic airlines during January-September, 2017 were 849.94 lakhs as against 726.98 lakhs during the corresponding period of previous year thereby registering a growth of 16.91%.

 - Chennai/Coimbatore/Hyderabad- Daily w.e.f. 3rd Oct 2017
 - Kullu/Chandigarh/Kullu - 6 flights per week w.e.f. 13th Oct 2017
 - Bangalore/Coimbatore/Bangalore- Daily w.e.f. 29th Oct 2017
 - Delhi/Chandigarh/Delhi - 6 flights per week w.e.f. 30th Oct 2017
- (v) On 06th October 2017, AIESL entered in to a MOU with SIA Engineering Company Limited, a company incorporated under the laws of Singapore and having its registered office at 31 Airline Road, Singapore 819831 (SIAEC) with the view to form a collaboration between SIAEC and AIESL for providing various aviation services in India e. g. Line Maintenance, Inventory Technical Management, Provision of Maintenance and Aircraft Type Training (to be offered and performed at AIESL's training facilities in India as well as SIAEC's training facilities in Singapore for the B737 and A320 fleet). At the end of the initial period of two years the collaboration would be transformed in to a joint venture between SIAEC and AIESL, provided it is found viable.
- (vi) Permaswaging equipment which were defunct for more than a decade (more than 10 years) made serviceable and is fully functional.
- (vii) **Marketing initiative:**
A two-tier fare structure for Free Baggage allowance of 30kg and 40kg respectively from select Gulf sectors to India was introduced for booking period 15th SEPT- 12th OCT 2017 and travel period from 15th SEPT- 20th NOV 2017. During October 2017, sale of pre booked meals was commenced from Jaipur and Mumbai.

6. Commission of Railway Safety (CRS)

- (i) During October 2017, statutory inspections were conducted before opening of **Five (05)** lines for public carriage of passengers.
