# Detailed Monthly information for the month of August, 2019

Important Policy decisions taken and major achievements during the month:

#### 1. Ministry of Civil Aviation

- A. Passengers carried by domestic airlines during Jan-July, 2019 were <u>825.64</u> <u>lakhs</u> as against <u>800.40 lakhs</u> during the corresponding period of previous year thereby registering annual growth of <u>3.15%</u> and monthly growth of <u>3.01%</u>
- B. Aviation Jobs:

Hon'ble MOS (I/C) Civil Aviation launched an "Aviation Jobs" portal (http://aviationjobs.co.in) on 29 August 2019. Given the regular creation of a number of aspirational jobs due to strong aviation sector growth in the last few years, a need was felt to provide a common web-based, user-friendly platform for job seekers to register their job interests across various civil aviation subsectors. At the same time, genuine companies/ prospective employers, who have completed their KYC under the Ministry of Corporate Affairs MCA-21 database, can register themselves on this portal to access the database of candidates. Candidates, from fresh and re-employment streams such as exemployees of Jet Airways, will be able to shortlist those suitable to serve their HR requirements as per their company policy through this online medium.

C. Dashboard of Ministry of Civil Aviation:

The Dashboard was developed on17 August 2019. It provides real-time data across a number of parameters on air transportation, including RCS-UDAN. It contains weekly, fortnightly and monthly updates on various other parameters, including photographic, numeric and textual depictions of status or progress made in airport development works projects.

- D. Bilateral talks were held between Govt. of Republic of India and Govt. of Poland on 14<sup>th</sup> August at New Delhi to discuss matters relating to Air Service Agreements and executed an MoU wherein Domestic Code Share arrangements have been agreed for the designated airline of each side to a total of not more than 10 points in the territory of the other party. Designated Airlines of Poland shall be entitled to operate domestic code share services to Ahmedabad, Cochin, Goa and Pune in addition to Mumbai, Delhi, Kolkata, Chennai, Bengaluru and Hyderabad.
- E. Bilateral talks were held between Govt. of Republic of India and the Royal Govt. of Bhutan to discuss matters relating to Civil Aviation on 26-27<sup>th</sup> August, 2019 at Thimpu. Both delegation finalized and initiated the text of Agreed minutes on Civil Aviation consultations with assurances of consideration by either sides to each other's requests. Delegation of Royal Govt. of Bhutan informed that Bhutan will fully support India's candidature to the ICAO Council.

#### E. TRAFFIC TREND:

Monthly Traffic Reporter for the month of July, 2019 has been prepared and uploaded on AAI website. The broad highlights of Traffic Reporter for the month of July, 2019 and (April- July) 2019-20 are as follows: -

### JULY, 2019 VIS-À-VIS JULY, 2018

During the month of July 2019, all Indian airports taken together handled 215.83 thousand aircraft movements (excluding General Aviation Movements), 28.90 million passengers and 293.01 thousand tonnes of freight. The aircraft movements and passengers have increased by 0.3% and 0.8% respectively while the freight has decreased by -3.2% during July 2019 over July 2018.

### (APRIL- JULY) 2019-20 VIS-À-VIS (APRIL- JULY) 2018-19

During the period of (April-July) 2019-20, all Indian airports taken together handled 840.78 thousands of aircrafts movements (excluding General Aviation Movements), 113.44 million passengers and 1135.00 thousand tonnes of freight. The aircraft movements, passenger and freight traffic have decreased by -1.7%, -0.3% and -4.6% respectively during the period under study.
