Construction of Civil Structure for PTB, ATC, Fire, Utility Building completed 100% as on date. Overall Physical progress of construction of project achieved is 93% and Financial status upto 77.44% as on 15/03/2016. DGCA team has inspected the site on 29/03/2016 in consideration of licensing of Heliport – PDC for completion/operationalisation is 30 May 2016.

(C) Gliding Centre at Hadapsar, Pune

The Project work has been completed in July, 2015. A review joint meeting was held at site under the Chairmanship of DG, DGCA among representatives from DGCA, AAI & PHL on 16th& 17th April 2015 at Gliding Centre, Hadapsar, Pune.
