- 1. Name of Post: Deputy Director General, BCAS, New Delhi.
- Scale of pay: Level 13A in the Pay Matrix.
- 3. Recruitment method: by deputation.
- 4. Eligibility: Officers of the Central Government/ All India Service (AIS):
- (A) (i) holding analogous posts on regular basis in the parent cadre or department; or
- (ii) with two years' service in the grade rendered after appointment thereto on a regular basis in Level 13 in the pay matrix or equivalent in the parent cadre or department; or
- (iii) with six years' service in the grade rendered after appointment thereto on a regular basis in level 12 in the pay matrix or equivalent in the parent cadre or department;

and

(B) possessing the following educational qualifications and experience:

#### Essential:

- (i) Bachelors' degree in any discipline from a recognised University or Institute; and
- (ii) minimum five years' experience in formulation, appraisal, execution or implementation, research, monitoring and evaluation of policy, programme or projects.

#### Desirable:

Two years' experience of work in -

- (i) an economic or infrastructure related matters;
- (ii) International co-operation; or
- (iii) security or aviation security.
- 5. **Period of Deputation**: Period of deputation including period of deputation in another, excadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed five years.
- 6. **Age Limit**: The maximum age limit for appointment by deputation shall not be exceeding fifty-six years as on the closing date of the receipt of applications.
