**Advertisement for the post of Member, Airports Economic Regulatory  
Authority of India (AERA)**

The Government of India in the Ministry of Civil Aviation has constituted the Selection Committee for the purpose of selecting Chairperson and other Members of AERA, under sub-section (1) of Section (5) of the Airports Economic Regulatory Authority of India Act, 2008.

2. Applications are hereby invited for consideration of the Selection Committee for making recommendations for selection of post of Member, AERA. The terms and conditions for selection to the post of Member, AERA are as under:

1.	Scale of pay	Pay Band 'HAG' in the scale of Rs.67,000/- 79,000/- (annual increment @3%) (pre-revised)
2.	Terms and Conditions	The Member will be governed by the terms and the service conditions as per Section 4 and 6 of the Airports Economic Regulatory Authority of India Act, 2008 and Rules made thereunder. The Member shall be whole-time Member.
3.	Essential Qualification and Experience	Persons of ability and integrity, having adequate knowledge of, and professional experience in, aviation, economics, law, commerce or consumer affairs may apply for the said post.  Further, any person who is or has been in the service of Government shall not be appointed as a Member unless such person has held the post of Secretary or Additional Secretary to the Government of India or any equivalent post in the Central or State Government for a total period of not less than 3 years.  For persons who are presently working or have retired from a Central Public Sector Undertaking or a Statutory Body, he should be working or should have retired at least as Executive Director or its equivalent in a Schedule 'A' CPSU/equivalent rank in Statutory Body.  For all other persons, they should have at least 25 years of experience in the relevant field.
4.	Tenure	The Member shall hold office for a term of upto five years from the date on which he enters upon his office or till he attains the age of 62 years, whichever is earlier.
