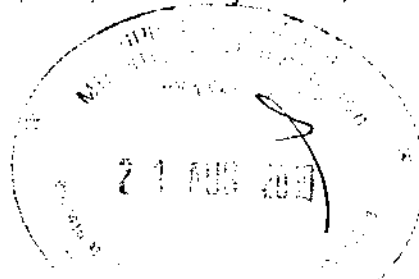

Detailed Monthly information for the month of July, 2019

Important Policy decisions taken and major achievements during the month:

1. Ministry of Civil Aviation

- A. Passengers carried by domestic airlines during Jan-June, 2019 were **706.80 lakhs** as against **684.83 lakhs** during the corresponding period of previous year thereby registering a growth of **3.21%**
- B. Two important aviation sector thrust areas have been highlighted in Finance Minister's Union Budget 2019-20 speech in Paras 14 and 15 on aircraft financing and leasing from Indian shores and development of domestic MRO services respectively. For drawing up a roadmap towards achieving the objectives separate rounds of stakeholders consultations have been held by Secretary, MoCA on draft proposals of the Ministry.

4. Airports Authority of India (AAI)

- A.** The Airports Authority of India (AAI) has earned a profit of Rs.210.83 crores after deduction of tax during the month of July, 2019.

- B.** Airports Authority of India (AAI) signed a contract with Aireon LLC to implement Aireon's air traffic surveillance service space based ADS-B in Mumbai, Chennai and Kolkata's oceanic airspaces.

- C.** Assessment of "Ban on Single use plastic items at 20 AAI Airports" by Quality Council of India started on 25th July 2019 as per the project timeline. Assessment of all 20 airports will be completed by 20th Aug 2019.

- D.** AIP Supplements on Realignment of Bhavnagar CTR, Rajkot CTR, Madurai CTR and Thiruvananthapuram CTR have been promulgated, with effect from 12th Sep, 2019. (Total 4 Supplements).

- E. AIP Supplements on Realignment of Thiruvananthapuram and Madurai Control Area (CTA) have been promulgated, with effect from 12th Sep, 2019. (Total 2 Supplements)
- F. During July 2019, ACI-ASQ survey were conducted at 24 airports. Out of 24 AAI airports, 22 have achieved score above the world average of 4.24. The average of 24 AAI airports is 4.64.

G. TRAFFIC TREND:

Monthly Traffic Reporter for the month of June, 2019 has been prepared and uploaded on AAI website. The broad highlights of Traffic Reporter for the month of June, 2019 and (April- June) 2019-20 are as follows: -

JUNE, 2019 VIS-À-VIS JUNE, 2018

During the month of June 2019, all Indian airports taken together handled 210.84 thousand aircraft movements (excluding General Aviation Movements), 28.93 million passengers and 273.43 thousand tonnes of freight. The aircraft movements and freight traffic have decreased by 0.9% and 7.9% respectively while the passenger traffic has increased by 4.2% during June 2019 over June 2018.

(APRIL– JUNE) 2019-20VIS-À-VIS (APRIL– JUNE) 2018-19

During the period of (April-June) 2019-20, all Indian airports taken together handled 624.94 thousands of aircrafts movements (excluding General Aviation Movements), 84.54 million passengers and 842.00 thousand tonnes of freight. The aircraft movements, passenger and freight traffic have decreased by 2.3%, 0.6% and 5.1% respectively during the period under study.
