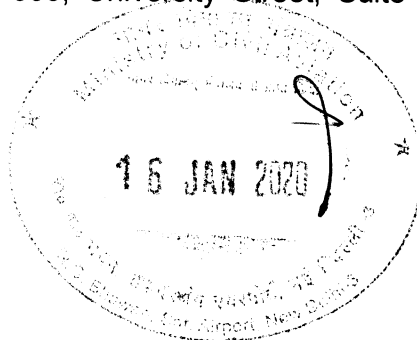

1. Ministry of Civil Aviation

A. Passengers carried by domestic airlines during Jan-Nov, 2019 were **1311.54 lakhs** as against **1262.83 lakhs** during the corresponding period of previous year thereby registering annual growth of **3.86%** and monthly growth of **11.18%**

D. The eGCA Project:

The Phase-1 services of the e-Governance (eGCA) project of Directorate General of Civil Aviation (DGCA) have been launched on 30th December 2019. The services have been launched through the new DGCA website, which will replace the existing website (www.dgca.gov.in). With this launch, the issue of Commercial Pilot License (CPL-A) with Flight Radio Telephony Operators License (FRTOL) and Instrument Rating has been automated. The applicants would now be able to fill up their flying details through DGCA portal, after getting themselves registered. Subsequently, after getting the flying details verified by the Chief Flight Instructors /Dy. Chief Flight Instructors, the applicants would be able to submit their applications for issuance of CPL-A online to DGCA. The DGCA would, after scrutiny of the application, issue license in plastic card form with QR code having all the necessary details. Rolling out the CPL-A in automated form would help in expediting the process of issue of CPL licenses, which would benefit about seven hundred aspirant pilots every year and would do away with manual handling and processing of applications. Besides issue of CPL-A, issue of Class 1 renewal Medical Assessment to the aspirant pilots has also commenced through eGCA. This will facilitate timely issue of Medical Assessment Certificate to the aspirant pilots

D. TRAFFIC TREND:

Monthly Traffic Reporter for the month of November, 2019 has been prepared and uploaded on AAI website. The broad highlights of Traffic Reporter for the month of November, 2019 and (April- Nov) 2019-20 are as follows: -

NOVEMBER, 2019 VIS-À-VIS NOVEMBER, 2018

During the month of November 2019, all Indian airports taken together handled 227.93 thousand aircraft movements (excluding General Aviation Movements), 31.21 million passengers and 279.58 thousand tonnes of freight. The aircraft movements and passenger traffic have increased by 3.7% and 9.2% respectively while the freight has decreased by 3.7% during November, 2019 over November, 2018.

(APRIL- NOVEMBER) 2019-20 VIS-À-VIS (APRIL- NOVEMBER) 2018-19

During the period of (April-November) 2019-20, all Indian airports taken together handled 1730.31 thousand aircraft movements (excluding General Aviation Movements), 230.82 million passengers and 2289.98 thousand tonnes of freight. The passenger traffic has increased by 1.8% while aircraft movements and freight traffic have decreased by 0.2% and 4.9% respectively during the period under study.
