## Detailed Monthly information for the month of August, 2018

Important Policy decisions taken and major achievements during the month:

### **1. Ministry of Civil Aviation**

- A. Passengers carried by domestic airlines during Jan-June, 2018 were **800.40 lakhs** as against **657.21 lakhs** during the corresponding period of previous year thereby registering a growth of **21.79%**.
- B. Bilateral talks were held between India and Afghanistan on 28<sup>th</sup> August, 2018 at New Delhi to discuss the matters relating to operation of air services. The text of revised ASA was mutually agreed and initiated. It was also agreed that the revised entitlements on frequency of services (passenger and cargo) and points of call would be agreed through a Memorandum of Understanding to be conducted between the two sides in near future.
