Detailed Monthly information for the month of May, 2019

Important Policy decisions taken and major achievements during the month:

1. **Ministry of Civil Aviation**

A. Passengers carried by domestic airlines during Jan-Apr, 2019 were **464.47 lakhs** as against **453.03 lakhs** during the corresponding period of previous year thereby registering a growth of **2.53%**

B. **Handling the fallout of grounding of aircraft:** Although scheduled airline aircraft capacity to the tune of 100 aircraft is being added annually, a series of unrelated events led to the progressive grounding of 122 aircraft registered with M/s. Jet Airways and M/s. Jet Lite with temporary suspension of the companies' full operations with effect from 17 April 2019 (midnight) due to financial difficulties. Another 18 Boeing 737-Max aircraft were grounded with effect from 13 March 2019 as a result of safety concerns raised in India and globally after the two fatal accidents of this aircraft-type operated by M/s Lion Air at Jakarta, Indonesia on 29 October 2018 and M/s. Ethiopian Airline at Addis Ababa, Ethiopia on 10 March 2019. In tandem, for each of the few serious safety incidents seen in 2018-19 in Airbus A320-Neo fitted with PW1100G engines operated in India, swift mitigating actions were taken by the safety regulator, Director General of Civil Aviation on all counts.

DGCA also took up monitoring critical parameters of Jet Airways/ Jet Lite in view of financial instability since October 2018. To reduce inconvenience to passengers and facilitate induction of additional capacity, some slots progressively vacated by Jet Airways/Jet Lite have been allotted to other domestic carriers on temporary basis for a period of 3 months. Committee of stakeholders was constituted for slots' allocation in an equitable and transparent manner.

Notably, for serving passenger interests and bridging the vacuum in seats-availability created by suspension of operations by Jet Airways, the Ministry in coordination with Customs authorities moved to remove the restrictions on re-leasing such de-registered aircraft to other domestic carriers without first exporting them out of India. It created a win-win situation for new lessee airlines, lessors and most importantly, the public at large. Resultantly, practically one aircraft capacity a day has thus been added to the Indian aviation skies since 18 April 2019. 42 inductions, as of 31 May 2019, by way of new aircraft or re-registrations of erstwhile Jet Airways aircraft have taken place. It has been ensured that a higher tally of aircraft is operating as compared to previous year 31 May 2018.

E. The Chairman, AAI unveiled the "Review of Traffic at Indian Airports: 2018-19". The broader highlights of the document are as follows:

- (i) Overall aircraft movements at all Indian airports during the year 2018-19 were 2.60 million which includes 0.45 million international aircraft movements and 2.15 million domestic aircraft movements. While overall growth of 12.1% was observed in aircraft movements, International and domestic aircraft movements have witnessed the growth of 3.4% and 14.1% respectively during 2018-19 as compared to 2017-18.
- (ii) Total passenger traffic handled at all Indian airports reached a new high of 344.69 million passengers, which included 69.48 million international and 275.21 million domestic passengers. Total passengers traffic witnessed growth of 11.6%, International and domestic passenger traffic have witnessed growth of 6.1% and 13.1% respectively during 2018-19 as compared to 2017-18.
- (iii) The total freight handled at all Indian airports during 2018-19 was 3.56 million tonnes, which includes 2.20 million tonnes of International freight and 1.36 million tonnes of domestic freight. During the year 2018-19, the total freight traffic witnessed growth of 6.1%. International and domestic freight have

registered a growth of 2.6% and 12.3% respectively as compared to 2017-18.

F. Workshop on Cyber Security of Aviation stakeholders

One day workshop was organized through National Critical Information infrastructure Protection Centre (NCIIPC) for Govt. stakeholders of Ministry of Civil aviation. The workshop was conducted on 22nd May 2019 at Indian Aviation Academy and was attended by representatives from Ministry of civil aviation, DGCA, AAI, Air India & RGNAU.
