NOTIFICATION

S.O.....Whereas Cessna Caravan 208B aircraft operated by M/s North East Shuttles Pvt. Limited met with an accident at Lengpui Airport in Mizoram on 04.05.2011 while operating from Imphal, Manipur to Lengpui, Mizoram.

And whereas it appears to the central Government that it is expedient to investigate and determine the cause and contributory factors leading to the accident and make recommendations to avoid recurrence of such accidents in future.

Now, in exercise of the powers conferred by the Rule 74 of the Aircraft Rule, 1937, the Central Government hereby directs that a formal inquiry of the said accident be held.

The Central Government is pleased to appoint a Committee of Inquiry headed by Air Marshal (Retd.) P.S. Ahluwalia with the following members to inquire into the circumstances of this accident:-

The Committee will complete its inquiry and submit its report to the Central Government within three months. Arrangements for accommodation, transport, secretarial assistance etc. to the Committee will be provided/ rendered by the Directorate General of Civil Aviation.
